### 3. Order Process

- **Placing Orders:** Orders can be placed through our website. You will receive an order confirmation via email once the order is submitted.
- Personal Information: Customers must ensure that all personal details, including delivery address and payment information, are accurate and up to date.
- **Order Confirmation:** Upon receiving your order, you will receive an order confirmation email detailing the artwork specifications, cost, and delivery information.

## 4. Unique Artwork

All artwork generated through our platform is unique and based on the individual user's inputs. As a result:

- Slight variations in color, design, or size may occur between the on-screen preview and the final printed product.
- The uniqueness of each creation means that **all sales are final** once the artwork has been generated and the printing process has begun.

## 5. Order Cancellation by Artistico Art Caspersen

Artistico Art Caspersen reserves the right to cancel any order for any reason **within 48 hours** of the order being placed. In such cases, the customer will be notified, and a full refund will be issued.



## 6. Inappropriate Content

Artistico Art Caspersen strictly prohibits the generation and submission of inappropriate or illegal images, including but not limited to images depicting pornography, violence, hate speech, or any other offensive content. Any orders found to contain inappropriate content will be canceled, and the customer will be refunded in full.

## 7. Cancellation Policy

Cancellations are permitted only **within 24 hours** of placing the order. After 24 hours, the creation process begins, and cancellations or modifications are no longer possible. To cancel your order within the 24-hour period, please contact us immediately at support@artistico.art.

## 8. Pricing and Payment
